To support action that will prevent fatal drug overdoses, and to otherwise mitigate the impact of substance use disorders on our society. Our SAFE Project team of experts strive for meaningful action through our programs, and lead efforts that are unifying, non-partisan and evidence-based. SAFE seeks meaningful metrics that strengthen our interdependent six lines of operation, and ultimately aim to achieve SAFE Communities and SAFE Campuses across the nation.

The underlying goal of the SAFE Campus program is to ensure that all six lines of operation are assimilated within all post-secondary schools. We want to ensure that these schools have programs to support current students in recovery. Students in recovery are the strongest advocates for this critical change and as such, SAFE Project has established a Leadership Academy to provide leadership skills, to educate on the values of servant leadership and to assist individual students and campuses to successfully develop programming to address the opioid fatality epidemic. The Leadership Academy program was established as a one-year fellowship for each student that would require them to work on a project specific to their campus or community. The program would also include one-year mentorship, a regional training academy and participation in the ARHE National Conference.

In order to address the stigma associated with addiction, SAFE Project has established a Speaker's Bureau program to go into secondary and post-secondary schools and talk to students and their parents about addiction, the science of addiction and the susceptibility to the disease. The goal of these programs is to provide students with tangible information to be aware of the risks and also to be willing to assist a student in trouble. Additionally, the program is also created to alert parents of the risks and signs of this disease. The SAFE Choices program has been presented at numerous schools throughout the country. The program has been presented in groups as small as individual health classes in local high schools to the entire Brigade of Midshipmen at the U.S. Naval Academy.
